General Terms

1. BACKGROUND

- 1.1. Welcome to ThePeerTutor.com (Web Site). This License details the Terms and Conditions (T&Cs) for all Users (Parents and / or Guardians, Tutors, Clients and Visitors as relevant and applicable) of the site. It also links to and should be read in conjunction with Our Privacy Policy (incorporating our Cookie Policy), which documents how we manage Your data and other information about You, how We manage Cookies and Your rights.
- 1.2. As we develop the Web Site, these T&Cs will evolve in line with the updated policies for all Users, including Parents and Tutors. You will be notified of changes to these T&Cs via the Web Site. The latest online T&Cs version will supersede all previous versions.
- 1.3. Our website is a Platform that provides a service that enables Tutors, working on a self-employed basis, to market themselves to potential Users/Clients that require tutoring services. The website is intended for those who are 18 and over as well as minors (those under 18). Minors are required to have adults aged 18 and above with parental rights, to provide the appropriate authorisation to use the website and ensure supervision at all times.
- 1.4. Tutors are not employees of ThePeerTutor.com Ltd they are self-employed and provide tutoring services via the ThePeerTuror.com Platform to Users. Tutors are expected to be compliant to UK self-employment regulations including but not limited to registration and reporting to HMRC of any income earned and have their own safeguards such as but not limited to insurance that protects them and Users in place, to use the Platform.
- 1.5. Users can be registered as Tutors or Users/Clients or both. To do so, all Users have to register on the Platform and provide the details requested and to use the Platform functionality. Users under the age of 16 must have Parental, Guardian or Carer with parental rights and consent to receive tutoring services and to use the Platform and it's services.
- 1.6. Using or registering with ThePeerTutor.com implies that you have read and understood the Privacy Policy and the Terms and Conditions that are applicable. If you disagree with the Privacy Policy and these Terms and Conditions, you should cease using the Platform.
- 1.7. This agreement applies as between you, the User of this Web Site and ThePeerTutor.com Ltd, the owner(s) of PeerTutor.com. Your agreement to comply with and be bound by these terms and conditions is deemed

to occur upon your first use of the Web Site. If you do not agree to be bound by these terms and conditions, you should stop using the Web Site immediately.

means a registered, approved User with an Account on ThePeerTutor Platform, who will conduct tutoring services via digital means to deliver online learning sessions to their contracted Client. Tutors over 16, but under 18 will require consent and an invitation from their Parent, Guardian or Carer to be able to tutor on the Platform. All Tutors are considered self-employed.

"Client"

means anyone registered on ThePeerTutor Platform wanting to receive tutoring services including a User who is registered and verified as a Tutor. This will be a direct contract between the Client (if over 18) and Tutor. If the User is under 18, then the contractual responsibility will lie with their Parent, Guardian or Carer (or person with parental responsibilities) and Tutor.

"License"

this Licence is granted for personal use by you and only you. You may not assign or transfer the rights conferred to you to without our express prior written permission. We reserve the right to assign or transfer all or any part of our rights and obligations under this Licence to any companies or other third party. Should we do so, we will give your sufficient notification of our intentions by e-mail or posted on ThePeerTutor website.

"T&Cs"

these Terms and Conditions

"Tutoring Services" means the provision of online tutoring in a secure digital space on ThePeerTutor Platform, by the Tutor to the User/Client that is customised to meet their individual requirements.

"Contract"

means the contract you hold between you and the Client/User you will be providing tutoring services to via ThePeerTutor Platform.

"Student"

means the means anyone registered on ThePeerTutor Platform wanting to receive tutoring services including a User who is registered and verified as a Tutor. This will be a direct contract between the Client (if over 18) and Tutor. If the User is under 18, then the contractual responsibility will lie with their Parent, Guardian or Carer and Tutor.

Once the Web Site has it's complete array of features and functions implemented (including, but not limited to a eWallet based Payment System, Learning Booking System, Meeting Room, Calendar, in-Platform messaging toolset) and prior to it's full operational launch, we will contact all Users that have either signed up on this Beta Web Site or indicated an expression of interest, via other means, to become a member of ThePeerTutor.com, we will contact you directly and / or via this Web Site with additional details on how to being engaging fully with other Clients and Users that have also registered at that stage.

21. Tutor Verification

- 21.1. At this stage, all Tutors are required to register and create an Account on the ThePeerTutor Web Site. Tutors sign up, on the understanding that they are considered as Self-Employed and not employees of ThePeerTutor.com Ltd or it's Partners. Where appropriate, Tutors will be required to provide:
- 21.2. Your personal identification details, including your name, address and acceptable photo id;
- 21.3. Your educational attainment(s) and certification, including teaching qualifications, Degree(s) held, A-Levels and GCSE grades attained, which will require a referee to verify and;
- 21.4. Your Disclosure and Barring Service (DBS) certificate, if held.

22. Tutor Obligations

- 22.1. When engaging with Users/Clients, You must comply with any technical and operational requirements mandated by ThePeerTutor and as amended from time to time and in accordance with these Terms. You agree to:
- 22.2. respond to and accept, within a reasonable timeframe, or manage any booking request(s) made by Clients via the ThePeerTutor Platform which You will be notified about via your Tutor Dashboard. You will only be able to commence lessons after ThePeerTutor provides a confirmation that the client wallet has sufficient credits to enable payments to be made to you. ThePeerTutor cannot be held responsible for any costs or

losses before approval to proceed with the tutoring session has been given on your via in-Platform email or via your Dashboard;

- 22.3. at the earliest opportunity, inform ThePeerTutor of any changes in Your circumstances that may impact on your ability to access the Platform, its tools or services:
- 22.4. accept full responsibility for any User related Disputes raised as a result of issues related to to the performance of your ThePeerTutor Tools affecting the performance of Your Tutoring Services;
- 22.5. provide Your Tutoring Services with all reasonable skill and care within your capability, in a timely manner bearing in mind the best interests of the User/Client and their requirements and in accordance with the highest professional standards, and within your personal abilities and subject matter competence;
- 22.6. Have access to and ensure good working order any computing and electronic devices used to engage with ThePeerTutor Platform and make use of its services and tools. Depending on the particular circumstances, ThePeerTutor and Tutor shall agree to resetting or postponing any further tutoring services, in agreement with the Clients wishes, which my require re-crediting the Client wallet, such that they do not incur any losses;
- 22.8. ensure that any data and information provided by You to ThePeerTutor is valid, complete and accurate at all times whilst these Terms of Engagement are applicable.

23. Tutor Responsibilities

23.1. Tutors will provide Tutor Sessions with all due diligence, that conform with the relevant clauses of this License and in compliance with all applicable local legal, statutory and regulatory requirements and standards of best practice;

- 23.2. It is the responsibility of the Tutor to take all necessary and appropriate steps to safeguard and protect the interests of the User/Client (especially and including) minors who are recipients of any tutoring;
- 23.3. Upon registration and creating an account and subsequently, Tutors are agreeing to the following statement of facts (warranties and representations): that all written and oral statements and information provided as evidence for the purposes of tutoring, including personal information, qualifications, credentials, references, background and suitability for providing the tutoring services, remain true, complete and accurate;
- 23.4. While registered on this Website You are prohibited to provide any services, including tuition (apart from those legitimately booked through ThePeerTutor Platform) to anyone, including but not limited to a sibling or other relative of a User/Client or to any individual that may be introduced, directly or indirectly, to the Tutor by a Client; and
- 23.5. It is the sole responsibility of the Tutor (if 18 and above) or their representative (in the case of those over the age of 16 and below the age of 18), to lawfully pay all income tax and national insurance contributions in a timely manner, in relation to all charges and sums payable to the Tutor by a Client. They shall be responsible for completing and submitting all relevant artefacts, including returns and any information as required by HMRC for payments received.

- 24.3. to use, publish, record, distribute, prepare extrapolated works of, display, reproduce or sell part or all materials and content, and the Intellectual Property Rights therein, in connection with the provision ThePeerTutor Services, as we see fit, in whatever format and through any digital or other medium;

- 24.4. and permissions to anyone, worldwide, who accesses any publicly accessible page(s) on the ThePeerTutor Platform, whether as a register User or Client or otherwise, non-exclusive, perpetual, royalty-free license to access, use, reproduce, distribute, prepare extrapolated works of, display and perform such material or content to the extent under the terms of this License;
- 24.5. You understand and acknowledge that Digital Classroom sessions may be recorded and You grant full permission for the storage and use of such digital audio or video recordings and that you waive any and all rights in and to all material and content that relates to you;

This License only grants you permission to use material and content as part of your tutoring engagements and services, on condition that it will be free from third party copyrighted content or that it is subject to third party proprietary rights including rights of publicity or rights of privacy, unless you have permissions or a formal agreement from the rightful owner(s), or have legal entitlement to use such material or content.
- 24.7. IPR in all content and material created by You in accordance with ThePeerTutor Platform shall be Your property. This clause shall not cover any content you share or make available to the Platform by any third party, including without limitation any content or material, communication, information or ideas as shared or made available by any other Users (including, Clients or Tutors).
- 24.8. The IPR as accommodated on ThePeerTutor website cannot be used, modified, copied, distributed, adapted, altered, or in any way dealt with, without our express written permission. You agree that all IPR in and relating to ThePeerTutor are owned by us.

Client/User Terms

25. Client Policy

- 25.1. At this Beta stage of development we are only accepting any expressions of interest on the www.ThePeerTutor.com Web Site, from Clients and Users, who are not Tutors.
- 25.2. As the Website and Platform development progresses and we near the launch of the full suite of services, we will provide details of how you can register and sign up for your unique account to enable you to view and

26. Client/User Verification

- **26.1.** At this Beta stage of development we are only accepting expressions of interest on the www.ThePeerTutor.com Web Site, from Clients and Users seeking tutoring services and, who are not Tutors.
- 26.2. As the Website and Platform development progresses and we near the launch of the full suite of services, we will provide details of how you can register and sign up for your unique account to enable you to view and engage with Tutors on the Platform. Typically, you will be required to provide, but not limited to, the following details to register as a Client/User on the ThePeerTutor Platform:

- **26.4.** Your banking details, including but not limited to sort code, account number to enable you to credit your eWallet that is associated with your unique User account on ThePeerTutor Platform.
